ADRE Forms and Policy Updates

SUBSTANTIVE POLICY STATEMENT No. 2022.01

Instructor Professional Development Requirements have been updated to allow Instructor Development Workshops (IDWs) to be completed through the Host Remote Live Streaming teaching method.

As was discussed during the December 2021 EAC meeting, SPS 2015.01 required most IDWs, but particularly those taken by instructors seeking approval to teach IDWs to be completed live in classroom. When asked, members provided feedback that an update to the SPS would be welcomed and the Department is happy to let you know the update has been completed.

SPS 2022.01, approved earlier this month, now allows all IDWs to be completed via Host Remote Live Streaming. See the full Substantive Policy Statement [HERE](#).



ADRE FORM CHANGES

Please use only the current version of forms. The most current version of a form is always made available on the ADRE website.

Changes were made to the **PRELICENSURE EDUCATION CERTIFICATE** in October, 2021. Pre-Licensure schools need to use only the updated form located [HERE](#).

Previous versions of certificates issued for courses completed on or after March 1, 2022 will not be accepted by ADRE.

The **LI-214/244 - DISCIPLINARY ACTION DISCLOSURE Form** was changed to reflect changes to Arizona law effective September, 2021. To ensure pre licensing students use the most up to date ADRE forms, you should refer them to the ADRE website forms page, [HERE](#).

All Applications, All Methods of Submission

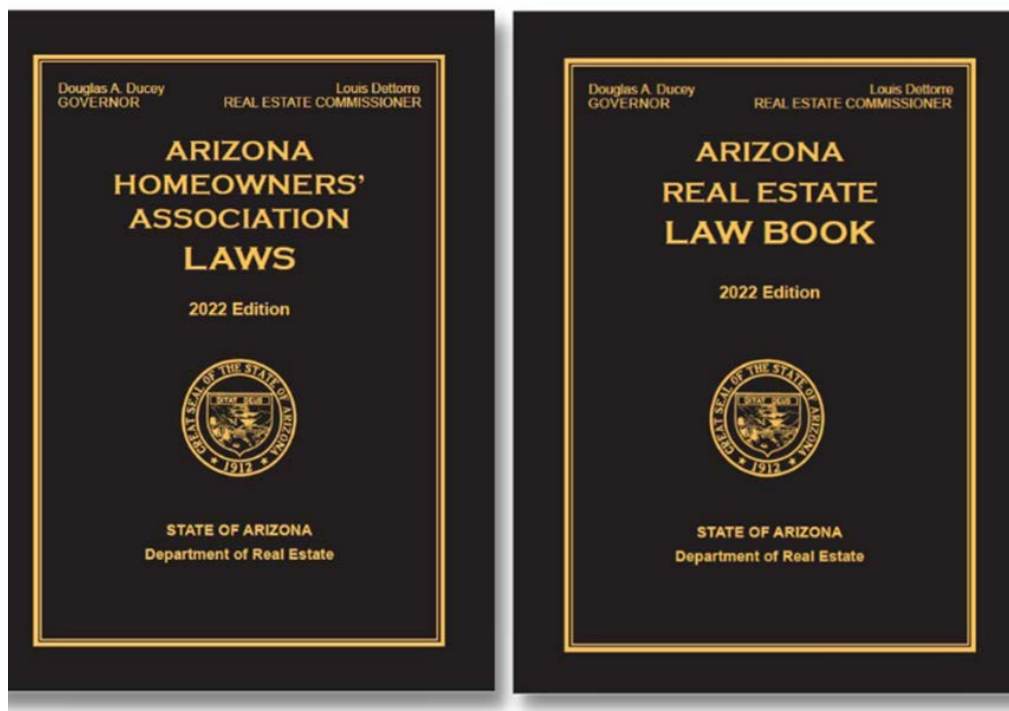
In addition to mailing and walking an application in to the office, applicants are now able to submit any and all types of license applications through the ADRE Message Center or Online License System.

New to being able to submit applications through the ADRE Message Center or Online License System are:

- Out-of-State License Recognition Applications
- Original and Renewal Applications with Disclosures

Certified Documents continue to be required for both of these two types of applications. As many of you know, during the pandemic many courts and state agencies began issuing and receiving Certified Documents in electronic formats. This was the case for the Department of Real Estate in receiving Certified Documents in 2020 and the beginning of 2021 and going forward, it made little sense for the Department to continue to require someone receiving Certified Documents by electronic means to print the documents out for the sake of having the documents in an paper format.
