## Renewing? Don't wait until the last minute...

When submitting a course, school and instructor renewal, don't wait until the end of the month to submit the renewal app.

A.R.S. 32-2135(F) generally requires these be submitted 30 days in advance of holding the course. Submitting renewal applications at least 30 days in advance will allow us to renew you on time and ensure there is adequate time for you to resolve any deficiencies.
