Commissioner Lowe welcomed new Member Rollins and noted a special thank you to past Members Frank Dickens and Scott Patterson for their time and service on the Real Estate Advisory Board.

- III. Approval of November 15, 2016 Meeting Minutes
Chair Clifton asked for a Motion to approve the November 15, 2016 Meeting Minutes. Upon a motion by Member Bowen, seconded by Member LaSlavic, the Minutes of the November 15, 2016 meeting were unanimously approved.
- IV. Commissioner's Report - Judy Lowe, Commissioner
- Reviewed Governors Ducey's roadmap and primary focus
 - Noted the Governor's savings expectation that every agency is asked to run at 10% less than the appropriated budget
 - Licensing walk-ins have been reduced by 35% since the online licensing began
 - The Department is currently at 84% usage of the online new licensee applications
 - The Department is seeing the benefits of technology improvements; all have visibility to attachments.
 - The Governor is looking for agency success stories
 - DC Dettorre noted if anyone would like copies of the Department Success Stores to please let him know.
 - ADRE has been on a campaign to get current updated emails for all licensees
 - New Law books were provided to the Board
 - 2018-2022 Strategic Plan has been completed and will be posted to the ADRE website
 - The new Broker Policy Manual should be done within 30 to 90 days and will include language for Property Management, Commercial and Land, in addition to Residential Brokers.
 - ASU is implementing a minor's program in Real Estate. Bill Gray is one of the instructors at ASU. The program is approved for pre-licensing real estate education.

- New Law Books may be purchased online at the ADRE website
 - ADRE launched a twitter account
 - There is a new email blast system for sending late breaking news and the bulletin
 - ADRE is actively conducting a customer service survey via links on the ADRE website and on employee's emails.

- DC Dettorre gave a brief overview of the four bills currently in legislature impacting the Department.

HB2039 Finders fees; apartment tenants

HB2072 Manufactured homes; real estate transactions

HB2067 Real estate licensing; exception; assistants

SB1060 Homeowner's dispute process

VI. Member Bill Gray gave a presentation on past Instructor Development Workshops (IDW's)

VII. Advisory Board Member Facilitator Reports

- Member LaSlavic provided to the Investigations Manager a business card with the names of two individuals suspected of violating state statute.
- Member Gray received a call about golf memberships. "can an agent be paid a fee for referring a member". Member Gray stated it would need to be paid through the Broker but he would confirm at the Advisory Board. Chair Clifton stated it should not be paid through the Broker and that it should be paid directly to the licensee as it is not related to the real estate transaction. Member Gray stated that the licensee should disclose that they have a real estate license, everyone concurred. Robin King noted that finder's fees are only noted in statute in relation to apartment rentals.
- Chair Clifton stated she is called all the time for advertising violations. She stated she is told that individuals who file a complaint do not hear back from the department and then continue to call her. The response is that advertising complaints must be on the written complaint form, and signed by the complainant.
